Key Updates on Emara Tax Portal!



1. What's New on Emara Tax Portal?

A. Under Required Actions – The dashboard integrates various VAT registration elements, aligning seamlessly with the guidelines set forth by the Federal Tax Authority (FTA) such as the expiry of

- ▶ Trade license
- ▶ Emirates ID of the Authorized signatory
- ▶ Passport of the Authorized signatory
- ▶ In addition to the above, the dashboard also integrates information such as:
- ▶ Pending penalties
- ▶ Additional information required for any applications submitted with the FTA including but not limited to such as VAT amendments, VAT refunds, and VAT returns.

B. Under Registration Overview – The portal's layout has undergone a comprehensive redesign to consolidate various registrations into a unified view. This enhancement enables you to effortlessly view, amend, or de-register across different categories, including:

- ▶ Corporate Tax
- ▶ Value Added Tax
- ▶ Tax Group
- ▶ VAT Clearing Company TINCO
- ▶ Excise Tax
- ▶ Warehouse keeper

Article 6(2)(b) of Federal Decree Law No. (7) of 2017 on Tax Procedures mandates registrants to inform the authority of any events requiring the amendment within 20 business days. Failure to comply may result in administrative penalties of up to AED 10,000.
