Mandatory Requirement to Update Primary Business Activity on Emara Tax Platform

The Federal Tax Authority (FTA) has recently released an important user manual requiring all registered taxpayers to review and update their primary business activity in the Emara Tax Portal under the Main License Details section. This is an immediate compliance obligation for all registered taxpayers aiming to simplify the business activity selection process by reducing the number of fields from 4 to 1, and by making search easier.

What Has Changed?

Prior to this requirement, taxpayers had to select their primary activity by selecting from the below 4 fields:.

With this change, taxpayers now have an option to search for their primary business activity by typing keywords/text. For instance, by typing 'manufacturing', multiple options would get displayed, and the taxpayer can select the option that closely matches the primary activity it undertakes.

Please keep searching and choosing, if you wish to add secondary activities(optional). A table will appear below classifying your selection. Action Required by Taxpayers

All taxpayers must log into their Emara Tax account and update their primary business activity. Failing to update this would restrict access to their taxable person profile.

Step-by-Step Guide to Update the Details:

- 1. Log into the Emara Tax platform using your credentials or UAE Pass.
- 2. Select your Taxable Person from the list.
- 3. Click View to open the dashboard.
- 4. A prompt will appear requesting you to select your business activity.
- 5. An option of "Remind Me Later" would also appear. However, this option can be chosen only once. On your next login, you must complete the update.
- 6. Use the search function in the "Update Business Activity" section to find and select the relevant business activity.
- 7. Mark it as your Primary Activity, check the confirmation box, and click OK.

Step-by-Step Guide to Update the Details:

- 1. This update on business activity is mandatory for all VAT registrants for compliance with FTA requirements.
- 2. The update can only be deferred once using the "Remind Me Later" feature. Before the next login, the taxpayer must update its primary business activity to maintain access.

MMJS Insights:

This requirement reflects the FTA initiative to streamline tax compliance and improve data accuracy by requiring businesses to declare a single primary activity on Emara Tax platform. It promotes better alignment between trade licenses and tax records, enabling more focused compliance oversight. Businesses should ensure their selected activity accurately represents their core operations. In case businesses are engaged in undertaking multiple activities, they may consider selecting the activity that represents their highest revenue stream or most significant operational focus as their primary business activity. It is pertinent to note that taxpayers can select additional activities as well; however, there can be only one primary activity.
